PFM reform, including decentralisation, aims to achieve more effective, and efficient management of government revenues, expenditures, assets, and liabilities. More recently, PFM reforms have included transformative processes such as an increased focus on transparency and participation as well as inclusion of gender and social considerations. There has also been a stronger focus on involving citizens through open budgets and participatory budgeting processes. In recent years, international finance institutions have increased efforts to introduce gender-responsive budgeting (GRB) within PFM systems. Indeed, although more PFM institutional reform is needed to advance gender equality, around 80 countries around the world are engaged in some form of GRB work. When economic and political systems are more aligned with women and men's needs, they are more effective and accountable.

NIRAS worked with the European Institute for Gender Equality (EIGE) to carry out an assessment of how gender budgeting is used in member state structural funds. The research helped to inform EIGE's future programming and work on supporting implementation of GRB throughout the EU. As deliverables, NIRAS produced reports on the state of play of gender budgeting in the EU as well as the budgetary process and potential for gender budgeting in the EU budgetary cycle, the Multiannual Financial Framework and the European

Semester, and Member State structural fund programmes. NIRAS developed a toolkit offering guidance to Member States on how to apply gender budgeting in planning, implementation, and evaluation of Structural Fund programmes that has been translated into 22 EU languages. We also delivered a tracking system for gender equality commitments in Structural Funds, which is currently under consideration in the EU Commission.




Gender-Responsive Budgeting (GRB) in Ukraine

Since 2013, NIRAS has been implementing the Sida-funded GRB project in Ukraine. The overall aim is to integrate gender budgeting processes into ongoing PFM reform in Ukraine. Gender budgeting tools are integrated into the regular budget process, performance-based budgeting measures, and the medium-term expenditure framework. This is being steered through new legislation and introduction of GRB tools and procedures. The project is designed to run concurrently on the national and regional levels to improve budget efficiency by better addressing women and men's service needs. In the beginning of 2019, the Ministry of Finance issued methodological recommendations on GRB for key spending units at state and local level. Thanks to collective efforts at all levels of government and the resulting outcomes, today Ukraine is recognised as one of the best practical illustrations of GRB.
